Greetings Fellow Spicebush Owners,

The Board hopes you have been able to survive another winter and that you are ready to spend some time at Spicebush in the coming weeks and months. Your Board met at the end of April and I would like to update you on our discussions.

#### **Projects**

As you know from previous newsletters, we have been working diligently to replace the vinyl flooring in the kitchens and making any necessary repairs to the subfloor. I am pleased to announce that we have completed this project and all the kitchens have new tile floors with some minor adjustments that need to be made to the threshold.

Working with the Club Group, we have also completed painting the exterior of the units and replaced any wood rot that we found. As you know, being located near the ocean in a warm, humid climate presents challenges in this regard. I am pleased to inform you the units look great and I am sure this will increase the longevity of Spicebush. Looking forward to the Fall, we will be focusing on the replacement of the mattresses on the beds and replacing the dining room table which could actually be the original one.

If you haven't been back in a while, I am pleased to share that the new foot wash outside the front of the units, the addition of pickleball lines on the tennis court and the relocation of the fire pit continue to be utilized well by the owners. These, along with the other improvements discussed above, are efforts to maintain and improve the Spicebush experience for you and our guests.

#### Sales/Rentals

The Board is continuing to discuss and investigate ways to increase the sale and rental of our non-revenue producing weeks. We are looking at listing available weeks on Airbnb and updating our website to make it more attractive to prospective buyers and renters. Having said that, you, as an owner, are entitled to special discounts when purchasing an HOA unit or special rental rates during certain seasons.

We have weeks for sale across all seasons, so be sure to review the package for weeks that might interest you either adjacent to a week you already own or even at another time. If you purchase an HOA week, you get 25% off the sales price and the dues are waived for the first year. If you are interested in renting an additional week, the Resort fee of \$75 and Housekeeping fee of \$175 are waived for owners.
